Frank Kurt Cylke, director of the National Library Service for the Blind and Physically Handicapped at the Library of Congress, was awarded the Newel Perry Award for 2005 by the National Federation of the Blind (NFB). The award is the highest honor the NFB bestows on an individual who is not a part of the federation.

Ann Friedman has announced her intention to step down from her position as director of Arlington County's Department of Libraries, which she assumed in 1995. The county is currently recruiting to fill her position.

Alex Hodges was recently appointed to a reference and instruction librarian tenure track faculty position at American University. Alex comes to AU's library after earning his MLS at the University of Maryland and working in a reference/vertical files position at the National Gallery of Art Library. Alex brings extensive instruction experience, which was acquired while teaching in the University of Maryland Libraries' freshman writing program.

Richard Huffine has received the Chapter Member of the Year Award from the DC Chapter of the Special Libraries Association. Mr. Huffine is manager of library services at the U.S. Environmental Protection Agency. Over the last year, he has been an active member of the local SLA chapter and took a leadership role in creating a new division in the association for government information professionals. Mr. Huffine has also been an active advocate for public library funding and responsible management of the public library system in the District of Columbia.

Heather Joseph has assumed the position of executive director of the Scholarly Publishing and Academic Resources Coalition (SPARC®). SPARC®, an initiative of the Association of Research Libraries, is an alliance of academic and research libraries and organizations working to correct market dysfunctions in the scholarly publishing system that have contributed to the high and rising cost of scholarly journals and inhibited the advancement of scholarship. She was formerly the president and chief operating officer of BioOne.

Carrie Russell, copyright specialist in ALA's Washington Office for Information Technology Policy, is the subject of the "Job of a Lifetime" article in the June 2005 issue of *College & Research Libraries News*. She reports that her primary mission is to educate librarians about copyright. She is the author of *Complete Copyright: An Everyday Guide for Librarians* and of the copyright advice column "Carrie on Copyright" in *School Library Journal*. She also teaches the online seminar "Current Copyright Issues Facing Academic Libraries" for the Association of College and Research Libraries.

Bill Turner, DCLA's ALA chapter councilor, has been elected from among councilors at large and councilors from chapters to serve a two-year term as an ALA Council representative on the Planning and Budget Assembly. His duties will include studying the budget and planning documents submitted to the ALA Executive Board, raising questions concerning them, and offering suggestions to the ALA Executive Board and the Budget Analysis and Review Committee.

Outstanding Librarians Recognized at 2005 Annual Banquet by Bill Turner

The Women's National Democratic Club was the setting for this year's annual banquet and awards presentation on May 9.

Fran Buckley Receives the Ainsworth Rand Spofford President's Award

Named in honor of the Librarian of Congress and first president of DCLA, the Ainsworth Rand Spofford President's Award recognizes outstanding achievement and contributions to the development or improvement of library and information services. This year the award goes to Francis Buckley in recognition of his lifelong contributions to the field of government information librarianship. For more than 25 years, Fran has written and spoken extensively on the importance of public access to government information.

Fran has made many contributions to library services. During an outstanding career of 40+ years, he has provided leadership in libraries in Detroit, Michigan; Shaker Heights, Ohio; and now as the newly appointed interim director of the District of Columbia Public Library. He was nominated for the Spofford Award even before he took on this newest challenge.

In still another of the challenges Fran has met and mastered, he was the first librarian to serve as the superintendent of documents at the Government Printing Office. He was in charge of the Depository Library Program, a nationwide system of some 1,300 libraries, in which government publications are available for public use free of charge. Fran also was responsible for the award-winning GPO Access service on the Internet, used by the public to retrieve an average of 5 million publications monthly.

Fran has been active in many professional associations including currently as a director of DCLA. He was a thoughtful and active member of the DCLA Strategic Planning Committee. Fran is also currently a member of the American Library Association Council, having been elected previously to that body several times. Next month he joins ALA's executive board, having been elected to that position by his colleagues on ALA Council.

Awards Committee member Anne Heanue presented Fran with the award.

Susan Randolph Receives the 2005 Distinguished Service Award

The Distinguished Service Award recognizes outstanding contributions by an active, current member of the DCLA. The selection criteria include active participation on DCLA committees or provision of other support to DCLA; a contribution in the form of an innovation that has endured or been adopted as an ongoing program of DCLA; devoted volunteer service at DCLA events; and demonstrated leadership in DCLA (as a board member or an interest group chair).

Susan Randolph is the recipient of this year's award. A member of ALA for more than two decades, she has served as editor of *Intercom* since 2002. She has greatly improved the quality and format of the newsletter and personally has written much of the copy for 34 issues. She has made the newsletter a source of information on professional development opportunities and a

ready vehicle for members to publish articles. She has dealt tactfully with the board, the membership, and with the printer to achieve each issue's objectives.

Susan also is developer and manager of a new membership database for DCLA. The database is set up by tables and queries that greatly will improve access to information on work and membership categories, renewal reasons, interest group and committee involvements, donations to student financial aid and program enhancement, offices held, and more. Working closely with the membership secretary, Susan has helped to redesign the DCLA membership form.

Susan is a four-year veteran of National Library Legislative Day, for which she has provided administrative and logistical support, including stuffing hundreds of packets of information for participants and legislators at stuffing parties and handing out packets and signing in and directing participants at the annual briefing day. She is a former chair of DCLA's Management Interest Group.

Bill Turner, Awards Committee chair, presented the award to Susan.

Alice Hagemeyer Receives the Community Service Award

The Community Service Award is DCLA's newest award. Candidates must have volunteered their library expertise to develop or improve a library service, program, or facility unrelated to their employment. Candidates also must demonstrate a significant, long-term level of service and commitment that directly benefited the community in the greater Washington area. The 2005 award goes to Alice L. Hagemeyer.

Alice has made major contributions on behalf of the deaf, locally, nationally, and internationally. She has held leadership positions in ALA's Public Library Association and Association of Specialized and Cooperative Library Agencies and other library and information science organizations, always with the personal agenda of advancing the best interests of the deaf community. She was president of the Library Friends Section of the National Association of the Deaf and was a delegate-at-large at the White House Conferences on Libraries and Information Services in 1979 and 1991. She served seven years on the Library Council of the Metropolitan Washington Council of Governments' Task Force on Library Services for the Deaf Community. She was a board member of Deafpride, Inc., and of the Maryland Association of the Deaf. She has chaired the Maryland Committee of the Friends of Libraries for Deaf Action (FOLDA) from 1989 to the present.

The Community Service Award particularly recognizes Alice for using her library expertise as a founder and a former president of the Friends of Libraries for Deaf Action, which assists libraries in promoting library access and quality products, programs and services for the local deaf community. Alice also is a founder and a long-time editor of the Friends' *Red Notebook: Library and Information Services to the Deaf Community*, which now has more than 2,000 registered subscribers nationwide.

Alice is secretary and program coordinator of the National Literary Society of the Deaf, a FOLDA partner. Locally, the Society maintains a list of speakers, authors and ASL storytellers from the deaf community and coordinates literary programs for increasing the appreciation of the deaf community, especially in young people, and for libraries and museums that provide information to the public about the arts, literature and history of the deaf community.


