I was the recipient of the [2015 Ann Heidbreder Eastman Grant](#), and used the funds to attend [ALA's Midwinter Meeting](#) from January 8 to January 12 in Boston, MA. What follows is a summary of my experiences at the conference.

January 9 kicked off with the [GLBT Round Table](#) Board Meeting. Although, I am not a board member, regular members are encouraged to attend to gain insight into how ALA roundtable business is conducted. The most interesting item of discussion (to a non-board member) was the continuing development of a toolkit for public libraries that wish to start collecting LGBTQ-related materials. The toolkit is approaching completion, and will be available from ALA very soon. This toolkit was then presented in further detail to the general ALA membership later that day at the News You Can Use Diversity session, and is an exciting first step for libraries that require assistance in this area.
