## Great Speakers, Great Attendance at Joint Spring Workshop by Bill Tuceling

More than 130 participants attended the day-long 2005 Joint Spring Workshop, held in the Mumford Room at the Library of Congress (LC) Madison Building on Friday, April 15. DC/SLA was this year's lead sponsoring organization, so its representative—Anne Marie Houppert chaired the event. Committee members from other sponsoring organizations included Laura Hjerpe and Bill Tuceling (DCLA), Eileen Rourke (DC/SLA), Carla Evans (LLSDC), and Anna Bohlin and Dave Pachter (FLICC).

From 9:00 a.m. until 12:30 p.m., four speakers from around Washington and across the country spoke about various aspects associated with taxonomies, ontologies, and the semantic web. The keynote speaker was Taxonomy Strategies founder Joseph Busch, who urged thesaurus creators to keep the list's structure simple, to write down the rules for including terms. to educate the list's users, and to tie the terms to the parent organization's strategy. structure, and budget. The morning's second speaker was Denise Bedford from the World Bank, and she advocated melding metadata taken from all parts of an organization into one hierarchical or faceted scheme. Next, Ramana Rao, CTO and founder of Inxight, made the case for using such color-coded visualization tools as a hyperbolic tree, a content terrain map, or a wide widget to see the breadth, depth, and inter-relationships of an organization's thesaurus terms. Associate professor Stuart Sutton from the University of Washington, Seattle, wrapped up the morning's session by detailing thesaurus construction techniques that accommodate shared and unique terms employed in the field of education by teachers and

administrators at all levels and in all countries.

After an hour break for a buffet lunch of sandwiches and salads prepared by LC's catering service, workshop attendees returned to hear three more speakers in the afternoon. Dan Dabney, senior director for taxonomies and subject access research at Thomson/West, used entertaining examples from the field of law to illustrate the differences between free-text and artificial languages, including how our ability to retrieve things depends on how someone has classified them. Next, Professor Jim Hendler, from the University of Maryland at College Park, suggested that the indexed articles' natural language (or an indexer's description of a graphic item) should suggest a scheme's terms from the bottom up instead of from the top down. The final speaker, the Department of Homeland Security's metadata program manager Mike Daconta, weighed the advantages and disadvantages of using formal versus on-the-fly taxonomies that computers and thesaurus users can understand. A final round of questions and answers wrapped up the workshop at 4:00.

Next year, DCLA is the lead sponsoring organization. LC's Mumford Room will be the venue again, and the date will be Tuesday, April 25. Based on the 85 surveys turned in by this year's attendees, popular topics for Joint Spring Workshop 2006 might be blogging/RSS feeds, digitization, library benchmarking/best practices, virtual/24-7 reference, or end-user research. It is a revision of the classic The Academic Library: Its Context, Its Purpose, and Its Operation.

The Library of Congress' National Digital Information Infrastructure and Preservation Program and the U.S. Copyright Office are sponsoring a group—The Section 108 Study Group—tasked with reexamining "the exceptions and limitations applicable to libraries and archives under the Copyright Act, specifically in light of the changes wrought by digital media." The Group's recommendations for possible alterations to the law are due to the Librarian of Congress by mid-2006. Laura Campbell, associate librarian for strategic initiatives at the Library of Congress, has said that "the success of the Section 108 Study Group is critical to the success of our digital preservation effort." The Group, which is co-chaired by Laura Gasaway, director of the law library and professor of law at the University of North Carolina, and Richard Rudick, former vice president and general counsel of John Wiley and Sons, will hold its second meeting on June 9 in New York City.

Shirley Loo reports that the **FirstGov.gov Reference Center** has a new section on libraries. I want to thank Liane for all her efforts and promote next year's event, which she has managed to book at the newly renovated U.S. Botanical Gardens on October 20. Please save the date.
